RE: Year-End Report for the 2017-2018 LAUC Research and Professional Development Committee

#### **General Charge**

For 2018-2019, the Committee is charged with fulfilling its standing charge, Article VIII. Section 1.e.2:

- 1. Solicit and review research proposals submitted to the University wide Research Grants for Librarians Program by LAUC members and recommending funding of proposals to the Office of the President.
- 2. Develop, monitor, and revise, as needed, procedures for carrying out the review of research proposals.
- 3. Develop guidelines for application to the University wide Research Grants for Librarians Program and recommend revisions as needed.
- 4. Advise the President and the Executive Board on issues related to research and professional development for librarians and address other subjects at the request of the President.

# Specific Charges for 2017-2018

- 1. Following the fall and winter/spring calls for proposals, review the effectiveness and usability of the newly-formatted grant guidelines and PDF forms. Make recommendations for changes or other updates to the LAUC Executive Board.
- 2. Continue to monitor its experience with the three different grant types, report any issues, concerns or problems, and recommend possible solutions.
- 3. Collect and post outstanding End of Funding reports from 2016 and 2017 grant recipients and post to the LAUC website.
- 4. Develop a short list of alternate funding sources (ILMS for example) and post to the R&PD page on the LAUC website.

# **General Charges**

The total amount of money available for represented librarians in 2017/18 was \$24,300. The total amount of money available for non-represented librarians was \$8,100. For the fall call for grant requests, the committee was able to fund 17 proposals; including 2 research grants, 1 mini grant and 14 presentation grants. 1 presentation grant was denied based on UCOP travel restrictions (AB 1887). The total funding given out for the first call is as follows:

For the spring call, the committee was able to fund 18 presentation grants. It is noted that the wording of the initial call focused attention on *presentation* grants, while in fact *mini grant* applications are also acceptable in the spring. This has been clarified to the incoming 2018/2019 R&PD chair. The total funding given out for the second call is as follows:

The total funds for the year awarded to represented librarians was \$23,281.81, the total funds awarded to non-represented librarians was \$1697.74. Please see the two attached reports (Appendices I and II), which were sent to UCOP, for a list of grants that were awarded. It was noted that a high percentage of applications for presentation grants were related to the "UCDLFX" Conference at UC Riverside. The R&PD Committee was pleased to be able to support so many UC librarians in their participation in that event and in support of cross UC collaboration. In addition, the committee notes the significant balance remaining for funds allocated to support *non represented* librarians. The 2018-2019 committee will be charged to consider how that might be directly addressed, and if information or messaging to this group is lacking with respect to funding opportunities.

# **Specific Charges**

- The committee continued to review the effectiveness and usability of grant guidelines and PDF forms. In general, these are working well. The group received feedback that more examples coupled with a web submitted version of the proposal form noting required fields would greatly assist in reducing the number of submissions missing critical information. A draft of such a web form was created at UCSF and the further review and establishment of this submission format is being included in the 2018-2019 Committee Charge.
- 2. The three grant types continue to be general well understood, and cover the requirements of professional development endeavors in the UC Libraries.
- 3. Outstanding End of Funding reports are being collected and will be posted in the LAUC website.
- 4. The short list of alternate funding sources was drafted, and will be finalized and posted as a resource in the 2018-2019 year.

# Randal S. Brandt, UCB

Bargaining unit: Member

Awarded \$4208

From the abstract: American writer David Dodge (1910 -1974) was a best-selling author of mystery and suspense fiction and humorous travel non-fiction who, until recently, has largely been forgotten. Since 2005, however, four of his novels have been reprinted and his last novel, which remained unpublished at his death, was published for the first time. This project will complete the research necessary for a book-length bio-bibliography of Dodge's life and works. With funds provided by LAUC, I propose to visit Columbia University, which holds the archive of Curtis Brown Ltd., Dodge's literary agent. The files related to Dodge in this archive contain significant correspondence, contracts, and memos that document his professional literary career. I also plan to visit some of Dodge's relatives (including a nephew and grand-nephew), interview them, and consult and photograph documents in their possession.

#### Lara Michels, UCB

From the abstract: The goal of this research study is to gain a better understanding of how the archival processing manual functions as a rhetorical tool in the professional archival community. This study is, in part, a response to calls from archival theorists for the archives profession to interrogate and make more transparent its traditional tools and practices and it is also inspired by rhetorician Carolyn R. Miller's statement that we should "take seriously the rhetoric in which we are immersed" (1984, 155). I will cast a critical eye on the archival processing manual and propose that the processing manual, like the archival finding aid, is a rhetorical genre and can be studied as such. Attention will be paid to the processing manual's role in the social construction of archival work and to how these manuals function as part of a social process that situates archivists broadly within the information professions and more narrowly within their own institutions. A mixed methods approach and design will be employed in order to ensure attention both to the texts themselves (processing manuals) and to how the archival community uses these texts to achieve institutional and disciplinary goals. Particular methodologies used will include textual analysis, historical analysis, longitudinal analysis, content analysis, and structured interviews (surveys). The outcome of this study will be an article submitted to one of the scholarly journals of the archival profession.

#### Mini Grant Awards

#### Matthew Roberts, UCI

Bargaining Unit: Member Awarded: \$415

As the Subject Specialist for the Critical Theory Archive (CTA) at UCI, I develop meaningful partnerships with scholarly institutions that reflect the collection strengths and priorities of the CTA. To facilitate this process, in the summer of 2017, I travelled to the Institut Memoires de l'edition contemporaine (IMEC) in Caen, France, to work with the Derrida Seminars Translation Project (DSTP). DSTP conducts a workshop each summer at IMEC, during which time team members and graduate students work through complex translation issues found in Derrida's seminar materials. UCI and IMEC collectively possesses Derrida's seminar materials. DSTP itself consists of faculty members from UC-Irvine, Emory, DePaul, Brown, and USC. As a result of my strong relationships with members of the Derrida Seminars Translation Team, and given my role at UCI, members of DSTP informed me of rather significant developments. Specifically, members of the Jacques Derrida estate decided that Derrida's seminars should be digitized, thereby extending the work done by the project, "Derrida's Margins," a website and online research tool for annotations from the Library of Jacques Derrida, housed at Princeton University Library. Members of DSTP entrusted me to facilitate discussions among UCI, Princeton, and IMEC in order to begin the digitization project. Hence, during the 2017-2018 academic year, my colleagues in Special collections and I initiated discussions with librarians and faculty members at Princeton. However, initial discussions with archivists at IMEC did not take place, and conversations regarding the digitization project have halted with Princeton.
