Residency programs provide valuable mentoring and professional development opportunities for new library graduates. This is especially in light of concerns in the academic library community regarding recruitment and retention. There are fewer than 30 such programs in America. We will be conducting a nationwide survey of current and former library residents, as well as residency coordinators in the United States. Questions will address program planning and decision-making, attitudes toward various aspects of library residency programs, cost/benefit of residency programs for libraries and residents, and the effectiveness of residency programs in context. Summary data collected from these survey instruments will help improve program planning and assessment for the fellowship program at UCSB. It will also serve as a model for other libraries that have existing programs, or that want to start a similar program
