Proposal Abstract (not to exceed 250 words):

Our team has been experimenting with different approaches to communicate with faculty about data curation issues. We have conducted focus groups, as well as presented a pilot data management presentation, and collected audience feedback. We have also reviewed the presentations, webcasts and online documents of many other academic institutions. One such example is the University of Minnesota¹, who used IMLS funding to create a data management course. In session 1, there is a campus researcher talking about the importance of file organization for data management. It is arguably the most persuasive part of the session, even though the researcher's participation is only by audio, no video.

Based upon this experience, we have come to the conclusion that faculty are most swayed by listening to other faculty. This conclusion is supported by library literature: "Librarians need to recognize who their potentially most effective spokespersons and advocates are, which psychological research seems to suggest is faculty talking to other faculty." However, there aren't many examples we could find of short, reusable videos of researchers talking about data curation issues. This is much more common in the Open Access realm, with the fantastic example of "Experts Speak" in the Netherlands. Locally, we have UC Open Access testimonials on eScholarship, with static pictures and quotes. The videos on open access provided by the UC Office of Scholarly Communication are plausibly more compelling.

Therefore, our goal is to make up to three video testimonials of prominent UCSC faculty discussing the importance and benefits of data curation. Considering the differing archiving concerns between the sciences, social sciences, and humanities, we will be engaging faculty from a variety of disciplines, including at least one from a non-science field. They would be selected both for their prominence in their respective fields and also for their passion for the topic and for their ability to speak persuasively.

Our intention is to make the videos reusable by other campuses both within and outside of UC (so we would avoid UCSC-specific branding or topics), to apply a Creative Commons license to encourage reuse, and to deposit the videos into eScholarship and YouTube for both archiving and accessibility. By editing the video footage into small modules (ideally around 3 minutes

each) we hope the videos will be useful in a wide variety of venues from their insertion into web pages and course management systems to their showing in seminars and classes to augment other material being presented.

Managing the building blocks and products of scholarship and research, including content created by UC scholars is part of the mission statement from the latest version of the Systemwide Plan and Priorities document⁶. These videos will directly support this system-wide goal.

Our assessment of the effectiveness of this approach may lead to more research into making persuasive appeals to campus researchers. We also hope that our approach mirrors the laudable practice of our UC colleagues in creating materials that can be reused with minimal effort.
