The manuscript entitled *Archival Resources of Republican China in North America: 1911-1949*, to be published by the Columbia University Press, has gone through two reviews by leading scholars in the field of East Asian Studies. Since both authors, Chengzhi Wang and myself, are not native English speakers, we have been advised by Press to hire a professional editor to proof read the entire manuscript to ensure that the English writing is up to academic standards. In addition, the Press has encouraged us to hire a professional indexer to produce a subject and name index to facilitate easy access to the contents of the book. The manuscript will be published simultaneously in both print and electronic by the Columbia University Press.

The bilingual guide aims to offer an easily accessible, cross-institutional introductory to over 330 Chinese studies archival resources in libraries and archives held by colleges and universities in North America. The guide is a "must reading for any student looking for a thesis topic on Republican China," (Esherick) and it "performs an important service in furthering the globalization of Chinese studies and advancing a process in which scholars of all countries search broadly for new sources to gain fresh insights into the Chinese past." (Esherick)

As librarians, Wang and I are consistently looking for ways to support teaching, learning, and research. The compilation of the guide is a rewarding process that advanced us professionally in many ways. We hope to broaden the effort to East Asian Studies in order to benefit more scholars and students.

Appendix 1: Suggested blurbs

The authors of *Archival Resources of Republican China in North America* are to be congratulated for producing this scholarly aid at precisely the time when scholar-teachers find it hard to keep up with all the research materials discovered and produced today. The problem of information overload and the burden of received culture have been increasing ever since the invention of printing and the means of coping with it has been a key feature of both the advancement of knowledge and its assimilation into the educational process.

Access to learning has always been dependent on the availability of texts, and the development of learning and teaching in historic times has been marked by the rise of libraries as centers of both study and teaching, as witness the spread of learning throughout medieval and early modern East Asia. Based on academies literally known as "Halls of Books" (*shuyuan*), physical access to texts by scholars and teachers was crucial and, because classics as the focus of a curriculum always had to be reread and reinterpreted in the light of contemporary knowledge, the scholar's effectiveness as a teacher depended on his being kept informed of new knowledge as well as new source materials. Access to source materials was important to learning and teaching.

Today with rapid expansion of technology, the problem of access to new knowledge and source materials is compounded by the vastly increased production of information and the attendant need for new media to serve the function of mediating and facilitating access to this expanded production. The present compilation by Wang and Chen should make a significant contribution to filling this need.
