# 1. LAUC Position Papers (N. Robinson)

UC Davis have reclassified AULs who now are ineligible to be LAUC members. This also affects positions at other campuses that resemble the UC Davis situation.

Nick recommends that CPG 2014/15 be charged to look into this situation, review the language in the bylaws regarding eligibility for membership and make recommendations for possible amendments.

Lisa Rowlison de Ortiz resigned on May 30<sup>th</sup>. UCLAS coordinating committee has asked us to submit and rank 2 names. One will be selected to complete Lisa's term, which runs through 2016. The names will be submitted today and CoUL will discuss at their meeting on June 13. 6 board members are reviewing 5 nominees.

# **UCB:** Open positions:

- Head of Acquisitions. The initial review date for this position is August 1, 2014.
- Humanities & Germanic Studies Librarian. The initial review date for this position is June 16, 2014.
- Head of Reference and Research Services. Accepting applications now through June 6, 2014 (extended deadline).
- Head of the Arts & Humanities Division. The initial review date for this position is July 1, 2014.
- Head of the Social Sciences Division. The initial review date for this position is July 1, 2014.
- Head of the Engineering and Physical Sciences Division. The initial review date for this position is July 1, 2014.
- Head of the Life Sciences and Health Sciences Division. The initial review date for this position is July 1, 2014.

There is concern among the union and faculty about the number of management positions and not subject positions. The Commission on the Future of the UC Berkeley Library recommended the money be spent to hire subject specialists, not management.

Moffitt Undergraduate Library collection has been integrated into the main stacks. Some of the new space will be surge space for the Business collection, which is also being integrated into the main stacks.

The Education and Psychology Library building is being torn down in the next couple of years. The new building will not include any space for the library. The Ed, Psych and Social Welfare librarians will be moving to the former Social Welfare Library. It will be called the Social Research Library and will house 10,000 highly used volumes.

NRLF is a big issue for the faculty but the Library Administration does not seem as interested in expanding NRLF. LAUC-B is curious as to whether LAUC Exbd would be interested in making a statement about the future of shared campus storage facilities.

# UCD:

At the quarterly membership meeting, the revisions to the PEARL documents were discussed. AULs were reclassified out of the Librarian series, so there is talk about removing their reviewing responsibilities.

Academic Federation put forward that non-academics should not review academics. Alternative reviewers would need to be found for the full peer review process. Campus will determine the review responsibilities of the AULs. Their membership status in LAUC will be an ongoing discussion with 2014/15 board. AUL title is not enough to be an academic title code, which is a membership criteria, it's merely a working title. Research criteria for Librarians have come up through the UL. The Vice Provost and campus administration have been very unhappy about the work that has been submitted in librarian packets that is outside the scope of the job description. The UL would like to tighten the criteria but this has met with strong opposition from the LAUC-D board. Matt has met with their Union Rep. Any kind of work is allowed to go into the review packet. It can only be evaluated for its academic merit and not its relation to librarianship. It's part of our academic role and standing in the academic senate that we have the freedom to do the kind of research or professional development as we see fit. There have been 8 retirements. There are new positions planned to replace the retirees but new positions are being planned as well such as Teaching and Learning Service Coordinator. UCI: Scott Stone is our new Research Librarian for Performing Arts. Scott began working at the UCI Libraries Monday June 2nd. UCLA: Brief descriptions of four staff and Librarian positions have been circulated to the Management Council for feedback before the complete descriptions are developed and recruitment for each begins. The positions are: Digitization Projects Coordinator, Library Assistant Audiovisual Preservation Specialist, Sr. Administrative Analyst, Preservation Dept **Director of Metadata Services** Health and Life Sciences Informationist Lead Web Developer Inquiry Librarian, Lead for Undergraduate Research Library openings: Head, Arts Library and Music Library - https://recruit.apo.ucla.edu/apply/JPF00257 Head of Special Collections Tom Hyry, is moving to Harvard. UCM: UCR: UCR is going to host a follow-up program: LAUC Southern Regional Meeting on LAUC Divisional Participation in Library Re-organization; Thursday, June 19, noon-2p.m. Orbach Science Library, Room 240.
