A. Summary and current status of the research project/activity

Screen sharing tools allow for sharing computer screens between participants; along with VolP (Voice over Internet Protocol) and depending on the tool used; video via webcam. In the summer of 2012 an online version of UC Irvine's popular Research Consultation Service (RCS) was piloted utilizing Google+ Hangouts and Join.me. Ten members of library staff were trained on how to navigate and use the tools, provided background documentation and given a chance to practice prior to being assigned online RCS sessions. At the end of the summer pilot, online RCS was fully implemented and the sign-up form for students was re-designed to make their RCS options clearer to understand. The remaining members of the Reference, Collection Development, and Education & Outreach departments were trained on Google+ Hangouts and Join.me.

I will be giving a presentation with Cynthia Johnson on "The Ins and Outs of Screen Sharing: Google+ Hangouts and Join.me" at ALA Annual 2013 in Chicago, Illinois, June 28 – July 1, 2013. The presentation will summarize the history of the work performed during the first and second phases of the pilot project. The presentation has been accepted by LITA (Library Information Technology Association.
