## LAUC-Berkeley Division Report, 2012-2013

# State of the Library

LAUC-B worked actively with the Commission on the Future of the UC Berkeley Library, formed by Executive Vice Chancellor and Provost George Breslauer and Academic Senate Chair Christina Maslach as a follow-up to the Library's Re-envisioning Initiative. LAUC-B's role was to articulate the needs and aspirations of the membership to the Commission. We shared the *Report of the LAUC-B Retention Survey Task Force* with the Commission and with the Committee on the Library, Berkeley Division of the Academic Senate. We invited the co-chairs of the Commission to our Fall Assembly, providing an opportunity for librarians to raise questions and concerns. ExComm was then asked to meet with the Commission in Spring 2013. We gathered input from the membership and created a presentation for the Commission to communicate LAUC-B's sense of urgency in addressing the library's budget cuts as well as to share our vision for the future of the Library. This presentation was posted on the LAUC-B website and shared with LAUC Systemwide. LAUC-B was subsequently asked to provide the Commission with an overview document, Library Services and Staffing Outlook, which the Commission reported was helpful in their deliberations.

  online system that houses faculty and academic staff peer review data, and creates and
  routes electronic merit and promotion dossiers on the Davis campus. Librarians are
  beginning to learn and use this campus tool.
- Implemented a peer review calendar change from academic to fiscal year
- Professional Issues Committee is developing a policy for approving professional leave
- Bylaws Revision was approved by the membership
- UC Libraries Systemwide Plan & Priorities FY 2013-2016 discussions

## **Staffing**

## **Library News & Initiatives**

- After participating in two DDA projects (Ingram/Coutts for 3 years and EBL for 1 1/2 years), UCI has found DDA to be a very cost effective model. This fiscal year we are continuing to monitor and assess our pilot with EBL. As of July 1st, the UCI Libraries have loaded approximately 6,000 titles into our local catalog, purchased 109 titles, and incurred short term loans on 824 titles.
- The UCI Libraries' Federal Depository Collection has migrated from Langson Library to Ayala Science Library as part of a large scale revitalization of the UCI Libraries' physical space. The space revitalization is expected to continue throughout the academic year.
- The UCI Libraries continue to promote local (UCI Space @ the Libraries) and CDL UC3-based data project support services and outreach to faculty and graduate students.
- Nearly 1200 new photographic images have been added to the Online Archive of UCI History, the digital
  archive created by the UCI Libraries to preserve and make available for research core historical records of
  the university (Available at UCI Space @ the Libraries).
- The UCI Libraries continue to experiment with the use of Google Hangouts as an open channel of research support.
- The UCI Libraries sponsored two very successful therapy dog group visits on the Libraries/Gateway Plaza: Ruff Days, Co-sponsored with the UCI Student Group, Active Minds (March 2013); and, Dog Days of Finals (June 2013).

- Howard Gillman, former dean of the University of Southern California's Dornsife College of Letters, Arts & Sciences, was appointed provost and executive vice chancellor of the University of California, Irvine, effective June 17, 2013.
- UCI ranked first among U.S. universities under 50 years old and fifth worldwide in a report released by
  Times Higher Education. It's the second consecutive year that the campus has ranked in the top five. UCI
  celebrates its 50th anniversary in 2015 and is the youngest institution in the prestigious Association of
  American Universities.

#### LAUC-LA Report, UCLA

The main change at UCLA over the last year was the recruitment for University Librarian that started in March, 2012 when Gary Strong announced his retirement. He initially was going to leave as of December, 2012, but was asked to stay on by the Chancellor and EVC until a replacement was hired. The EVC initially chose not to have a librarian on the search committee, but reexamined that. The Search committee did involve library staff and the LAUC-LA Executive board and other stakeholders in the interview process. Two candidates were interviewed, and Virginia Steel of UC Santa Cruz was selected. She started at UCLA on July 15<sup>th</sup>.

At our fall meeting we honored 10 new librarians who were hired over the last year. At our spring meeting we honored three librarians who were retiring, and 11 librarians who were in temporary positions were granted career status. I believe 4 librarians retired over course of the year.

Because the statewide LAUC Assembly was held at UCLA, the LAUC-LA Executive Board assisted LAUC President, Keri Botello with setting up a local arrangements committee. Our statewide representatives organized several brown bags to discuss the Priorities document that was the theme for the Statewide Assembly. The Mentoring Committee organized Affiliated Units Lightning Presentations such as from the Hispanic American Periodicals Index, the Ralph J. Bunche Library and Media Center and SRLF. The Committee on Library Plans and Policies has made progress with the library administration in working to make the library environment safer. The Committee on Programs put on a tour of the campus underground tunnels. Programs committee also facilitated the Fall and the Spring Membership meetings.

We passed a bylaws change that will allow us to have virtual LAUC-LA committee meetings. We also appointed an Ad Hoc committee to set up the procedures. We instigated another change regarding the timing of the steps involved in implementing bylaws changes. The Committee on Professional Governance tackled some issues this year by looking at officers' roles, in particular that of the Secretary, and the possibility of creating a new Treasurer position. The Mentoring Committee included library staff in the program they put on for affiliated libraries.

Called "the Carville of California" by the New York Times, Democratic political consultant Garry South has donated his extensive campaign archives to the UCLA Library. The UCLA Library Simul8 Group has released a set of apps that work across web, tablet and mobile devices. These apps provide new interactions with our extensive article databases. Two UCLA libraries were open twenty-four hours a day during tenth week or finals of the winter quarter.

# LAUC Santa Cruz Division Annual Report, July 2013

#### **Divisional Activities**

**Library Budget:** The library budget for fiscal year 2012/13 remained the same as last year (FY 2011/12). However we anticipate a potential 7% reduction for 2013/14. Overall the library budget will have declined 40% from 2009-2014.

**Library Hours Fee Referendum:** Late evening, Saturday, and extended hours during finals week are funded by Measure 42, a temporary library fee passed by students three years ago. The library launched a successful petition drive with help from librarians, staff and student employees to renew the fee. The ballot proposal was withdrawn when the campus EVC stepped in at the last minute with a plan to provide funding for two years. The library must still find a way to fund the 3rd year.

**PAPA/LS Documentation:** After wide consultation and two brown-bag meetings, LAUC members voted to endorse the changes to PAPA/LS (Procedures for Appointment, Promotion, Advancement and Career Status, Librarian Series), which removes the provisional designation. CAPA will work with library administration on remaining issues.

**Other:** Several members attended the CDL Data Curation Workshop held in Oakland and Irvine in November 2012. LAUC members provided helpful input on the new Advisory Structure and input and comments regarding the CoUL Plan and Priority document.

Committee on the Library and Scholarly Communication (COLASC): COLASC started the year discussing plans for the draft Open Access policy, the collections budget and overall library budget. The committee invited Chair of the Committee on Research to discuss possible collaborations with the library. The committee also asked a representative from University Relations (Development) to discuss the campus capital campaign. The year ended with a budget discussion with the campus EVC, regarding funding for the library and the detrimental impact of continued budget cuts. COLASC Chair Roberto Manducci is stepping off the UCSC committee to serve as Chair of UCOLASC.

The past year has brought very large changes to the UCSD Library. A brief listing of the major changes are as follows:

- The UCSD Libraries completed the transition over the last few years from a collection of distinct subject-based libraries to one centralized UCSD Library, organized into functional programs.
- Externally, the biggest result of these changes is the closing of physical library locations. The
  Scripps Institution of Oceanography and the International Relations/Pacific Studies Libraries
  physically closed their locations. The print collections (hundreds of thousands of volumes) are
  currently being integrated into the larger collection. UCSD is down to two physical locations
  open to the public and two storage locations.
- Internally, the reorganization of our operating structure meant that everyone in the
  organization was given new "assignments." Many LAUC members will be adjusting their roles,
  and nearly all will have a new reporting structure. The general idea is that instead of subject
  libraries each doing their own outreach/instruction/reference/collection development/access
  services/etc., each of those functions would have its own program and be done centrally. All
  employees received their new assignments in May. The transition is expected to take at least
  through the end of 2013.
- No staff members were laid off during this process. As a part of the organizational restructuring, 28 positions will be opened to be filled (some internally, some part time, some temporary) in the near future. Included in these positions are 8 permanent and 4 temporary full-time librarian positions (i.e. LAUC members) to be filled externally.
- During the past year, LAUC-SD gained 0 new members and lost 6. Retiring were Peter
  Brueggeman (28 years at UCSD), Brad Westbrook (19 years), Sanae Isozumi (15 years) and Tony
  Harvell (9 years). Leaving for new jobs were Ardys Kozbial (8 years) and Patrick McCarthy (5
  years). Four of these members were program directors, leaving large holes in the current
  management structure. Recruitments are in process for 2 of these positions.

During this turbulent time of restructuring, LAUC-SD has continued to offer numerous programs to its members. Of note:

- R&PD committee brought in Barbara Tillett from LoC to speak about professional development.
- Diversity committee held numerous film screenings and book club discussions.
- Mentoring committee hosted a shadow-a-librarian day for library school students and recently had approved a LAUC-sponsored graduate internship program.
- 4<sup>th</sup> annual service recognition was held to recognize LAUC members publically for their excellent service to the library.

# Membership

During the course of the academic year, two new LAUC members joined the staff: Sarah McClung (Collection Development, January) and Evans (Whit) Whitaker (Education & Liaison Librarian, February). LAUC-SF's membership now numbers ten, including our University Librarian, Karen Butter. Another non-LAUC position (Research Informationist) was filled in February, and LAUC members participated in the interviews for the three new positions in Fall 2012.

#### **Procedural**

For the first time, our librarian based at UCSF Fresno, Judy Kammerer, served on the LAUC-SF executive board. We decided that technology could bridge the distance gap well enough to enable the connection between San Francisco and Fresno. Starting in October, we began connecting with the Movi videoconferencing system in our conference room, and have found the sound and picture to work well. This test period helped prepare us for Fall 2013, when Judy takes over as Chair.

Minutes from 1999-2010 were moved from the LAUC-SF web page to a Word file in a shared directory.

#### **Activities**

Members met monthly throughout the year. Our UL, Karen Butter, visited two of our monthly meetings. The first visit was to give us the background on and kick-off our discussion of the UC Libraries Systemwide Plan & Priorities 2013-2016 document. On her second visit, she outlined changes in how UCSF will process librarian packets for merits and advancement (using an online system, Advance).

We discussed the UC Libraries Systemwide Plan & Priorities 2013-2016 document over the course of three meetings, and submitted our division's report to the prepared questions.

Member Judy Kammerer submitted a statewide research grant proposal for her project, "Development of a comprehensive LibGuide and WordPress website to highlight, categorize, explain, and facilitate access to Translational Medicine resources originating at all ten University of California campuses".

In the spring we began the process of setting up a brown bag series where LAUC members and other library staff will share their expertise and knowledge on core issues related to the profession. Topics and speakers are being tracked on our wiki space, and sessions will be planned starting Fall 2013.
