Statement of Interest

I'm delighted to accept the nomination committee's invitation to submit my candidacy for LAUC Vice President / President-Elect. I have participated in several LAUC-LA and LAUC statewide committees and task forces over the course of my 10 years at UCLA, and it's always been a pleasure to collaborate with colleagues across the state to address issues of concerns to our profession. But you might know me best from my recent work on the UC-AFT negotiating team. That experience has taught me that librarians united can achieve anything, and there are many challenges that the LAUC Executive Board will be facing in the coming years, and I'd like to contribute to LAUC's response to those challenges. For example, the proposed APM-011 Policy on Academic Freedom for all UC academic appointees will be approved before long, and LAUC will need to contribute to the articulation of rights and responsibilities in situations specific to librarians, such as acquisitions and collection management. On this issue and much more, I'm eager to see LAUC become ever more assertive in its shared governance role, both within the campus libraries and throughout the wider UC academic community.

My current professional focus is FORCE11, where I serve on the Board of Directors, and am heavily involved in the FORCE11 partnership with the UCLA Library to plan and produce the FORCE11 Scholarly Communication Institute at UCLA in August 2019.

I am also active in the American Library Association (ALA) and the Association of College and Research Libraries (ACRL), and I have attended their annual meeting since 2009. I was a member of ACRL's Research and Scholarly Environment Committee, July 1, 2013 – June 30, 2015. I was active in the Copyright Education Subcommittee (CES), in the ALA Office of Information Technology Policy (OITP), from 2010 to 2018, and served as Chair 2014 – 2015. The group morphed into the Copyright & Legislation Education & Advocacy Network (CLEAN), and I am still an active member.

I was a contributor to the Copyright Review Management System (CRMS) "World" initiative, a project supported by an IMLS National Leadership Grant and conducted by the University of Michigan. I conducted 5403 reviews, with 3193 public domain works made publicly available through my reviews.

I have been a senior member of the Academy of Health Information Professionals (AHIP) within the Medical Library Association, and I attended the MLA Annual Meeting every year from 2000 through 2008. I have been active in the Medical Informatics Section of MLA, where I served on the Executive Committee as Webmaster from 2001 - 2003.

I served as Chair (2008-09) of the Librarians in Medical Education (LiME) Northeast section, part of the Group on Educational Affairs (GEA) of the Association of American Medical Colleges (AAMC). Also participated in a joint task force of LiME and AAHSL, reviewing online tutorials in Health Information Science (2008-09).
