LAUC Executive Board Transition Meeting SCLG Year-End Report 2021-22 Prepared by Brian Quigley

SCLG meets on the 2nd and 4th Fridays of the month via Zoom. Meeting notes are available on the Shared Content Leadership Group (SCLG) Meetings page. SCLG is charged to make decisions in the areas of UC-wide collection development and management.

Roster changes:

- Lisa Mackinder was appointed Assistant Director of Systemwide Licensing in March 2022.
- Ellen Finnie retired as Director of Shared Collections on September 1. Lisa Moske has joined as the interim CDL representative until the new Director of Shared Collections starts in October.
- Allison Scott also retired on September 1. Megan Rosenbloom has joined as the new UCLA representative.

Highlights from 2021-22 SCLG meetings:

- A subgroup developed a diversity, equity, and inclusion statement that was approved by SCLG,
 DOC, and CoUL. This DEI commitment has been incorporated into the group's charge.
- Transformative agreements and open access investments were a significant focus this year.
 - The group reviewed and provided feedback on several new transformative agreements including ACS, IEEE, Nature, Sage, and Cell/The Lancet from Elsevier.
 - The group also approved renewing the Cambridge University Press, Journal of Medical Internet Research (JMIR), and PLOS open access agreements.
 - We also approved continued open access investments in arXiv, Open Education Network, and SciPost as well as new investments in MIT Press Direct to Open, University of Michigan Press Fund to Mission, and the American Indian Culture and Research Journal.
- SCLG received updates from and provided feedback to the Systemwide Print Collections
 Management Strategy Working Group throughout the year. As part of that working group, I
 previewed the faculty engagement plan and <u>UC Print Futures Handout</u> for the LAUC Executive
 Board in November.
- At CoUL's request, SCLG charged JSC to assess whether to continue purchasing post-termination
 access rights to ScienceDirect content. SCLG discussed the assessment and submitted a
 recommendation to not purchase post-termination access rights to ScienceDirect content. CoUL
 approved their recommendation.
- Based on the JSC survey and priorities, SCLG discussed and approved systemwide purchases to be made on augmentation funds and CDL year-end funds. Those purchases are outlined in the CDLINFO news story on FY21-22 New Resources - Annual JSC Survey.
- SCLG charged the Ebook Strategies Team to conduct an assessment of major ebook packages and also decided to charge a group to examine ongoing systemwide OCLC costs.

Serving as the LAUC representative to SCLG from 2019-2022 has been an honor and a wonderful learning experience. Thank you to LAUC for the opportunity.
