With this letter I am applying for a LAUC Mini Grant, as a member of the UC-AFT bargaining unit. I plan to use these funds to travel to the annual Digital Humanities Summer Institute held in Victoria, British Columbia, taking place from June 6th to the 10th, 2016, where I will be partaking in the five-day intensive workshop, Linked Data and RDF.

I am pursuing this research activity because of my involvement with UCI's NEH-funded grant project, Piloting Linked Open Data on Artists' Books. The initial pilot grant project's documentation is due in May, 2016; however, attending the Institute in June, 2016 will be instrumental in implementing ongoing, scalable workflows at UCI that will be shareable to other institutions. The workshop's topic of Linked Data and RDF is particularly appropriate for our pilot project, as we are utilizing linked data technology, specifically RDF-XML, to enhance the descriptions of a selection of artists' books in our collection. My role as creative lead on the project has given me a basic theoretical knowledge of how linked data and RDF works; however, having an immersive learning experience would make my decisions on content, user interface, and metadata more informed. Secondly, I would be able to shoulder some of the production work, while training others at my institution (as well as sharing training documents to the library community at large) in the principles of RDF and linked data creation.

My background and training on this area has been acquired through the grantwork for the pilot, which has been steadily progressing since April, 2015. I have been involved in selecting the artists' books for the pilot, choosing derivative images, gathering linked data information from controlled vocabularies, and advising on metadata, systems, and digital assets.

I have also been appointed recently as the interim Digital Humanities Coordinator at UCI. In this role, I have been tasked to provide a business case for ongoing production stemming from the pilot artist book project. Attending the Institute would greatly enable me to accurately judge the feasibility of incorporating these workflows in UCI's digital collections on an ongoing basis, while learning practical skills that will give me a better ability to enhance the work of the pilot project. Furthermore, attending this institute will enhance my contributions to the UC Library's mission, particularly as notated in the Systemwide Annual Plan and Priorities, 2015
