Technology has changed the nature of libraries and how librarians teach information literacy. How can librarians in academic libraries address the challenges and opportunities that continue to emerge with new technologies? Often, students start with Google when beginning their research. They feel knowledgeable enough to find what they need when it comes to general collection materials such as books and articles. Many do not know that the materials collected by Special Collections exist in an academic library. Materials in Special Collections have traditionally been documented in online catalogs and finding aids. The University of California Santa Barbara has been working to make these materials more discoverable by utilizing new technology such as Archivists' Toolkit, ArchivesSpace, Online Archive of California, and Aeon.

Both Archivists' Tookit and Archives Space are open source data management systems that support archival processing and access to the materials. With the advent of increased digitization of finding aids to collections, the Online Archive of California provides free public access to detailed descriptions of primary resources.

Aeon, a workflow management sytem for special collections allows researchers to submit requests for items directly from the online catalog and finding aids. This is very similar to the interlibrary loan system that is already familiar to librarians. Aeon will allow our materials to be more efficiently found, requested and utilized across the world. Also, researchers will be able to use Aeon records for citation information regarding materials consulted.

Additionally, we will explore how our instruction services can help identify ways in which special collection resources are available for research at the University of California-wide institutional repositories. And, we will review the literature to identify how other special collections libraries are responding to emerging technologies, and revising their information literacy curriculum.
