## Candidate Statement

I appreciate the opportunity to run for the position of LAUC VP/President-Elect and to continue my deep commitment to our professional organization. My career-long active involvement in LAUC, both locally and statewide, as a librarian at UC has provided me with both a broad overview of, and direct experience with, LAUC and all of its committees and work. My most recent term as Statewide Secretary (2021-2022) was particularly fulfilling, as it gave me the chance to meet monthly with colleagues across the UC and learn about member experiences at different campuses. My tenure on the LAUC-B Research & Professional Development (R&PD) Committee will be invaluable as preparation for my role chairing the statewide R&PD committee as it administers the LAUC Research Grant program; my term as LAUC-B Executive Committee Vice Chair/Chair (2015-2018) – for which I chaired monthly meetings, coordinated discussion among membership on issues important to UCB librarians, planned our local assemblies, and participated in Statewide Executive Board conference calls - has provided me with relevant experience listening to members' ideas and concerns, facilitating discussion, and keeping membership apprised of any pertinent developments; and my CAPA service has given me the opportunity to learn about the great work of my colleagues at Berkeley and gain a solid understanding of the review process.
