## Proposal Abstract (not to exceed 250 words):

The importance of print newspapers and journals as one mechanism for the expression of colonial dissatisfaction, alienation and associated rise of nationalism in French India remains an understudied fact. The beginning, apogee and end of French press in India can be understood as one valuable tool that would allow us to interrogate the complex mechanisms that eventually lead to the rise of Indian and Indo-French national identities. French language periodicals that were published in French India (1701-1954) remain an excellent source of such information. These periodicals provide us with a new perspective on mechanisms of colonization, cultural production, public sphere and subsequent decolonization within the French held territories of India. These periodicals are often overlooked by researchers in North America who study colonial theories due to the difficulty of access. The proposed project will address the difficulty of access issue in several ways. First, under this project a comprehensive web-bibliography of these French periodicals of colonial India will be created. The majority of these non-catalogued periodicals are scattered in the public libraries of former French colonial enclaves of Pondicherry, Chandernagore, Karikal, Mahe and Yanaon in India. Second, a research paper related to the complex processes of French colonization in India will be presented in an academic setting. I believe that this project will enable the North American specialists that are interested in studying the specificities of French colonization add an unique dimension to their research on social conditions and popular culture in the colonial India and the colonial power-France.

## **Project Goals:**

Note: The uniqueness of this project is defined by the fact that an annotated bibliography of French language periodicals from French India does not exist.

- 1. To create an annotated bibliography of Indo-French Periodicals that were published in French India from 1701-1954.
- 2. In order to improve the access to this bibliography, the mounting of this bibliography as a searchable database on the web is planned.
- 3. Optional-If possible, include images of the title pages of the periodicals within the proposed bibliography.
- 4. Optional- Not to be funded by LAUC Research Grant money: To microfilm if possible up to 4 titles of French language periodicals from the colonial period of India.

#### **Introduction:**

India achieved her independence from her colonial master Great Britain in 1947.

However the vestiges of European colonial empires continued to persist on the Indian subcontinent in the form of French and Portuguese colonial enclaves. The French exited the Indian sub-continent in 1954, while the Portuguese were expelled by military means in 1961. 

During the course of colonization, these powers, despite their minor roles in the sub-continents history, had left behind an extensive documentary heritage. Within this heritage, I would also include the periodicals of the French and Portuguese colonial era that were published in French and Portuguese languages. The subjects of inquiry for the purpose of this grant will be the French periodicals of colonial India that were published in L'Inde Française.

Some of these periodicals continued to be published for a limited time after the reunification of these colonial enclaves with the Republic of India. Partially, the language policies of the Indian Union along with the demise of the subsidies from the former colonial masters can be held responsible for that which led to the demise of these periodicals as the use of

either the local languages, Hindi or English was promoted in these unified territories. The fact remains that these periodicals eventually ceased to exist and copies of them continue to be held in local libraries, in local archives in India and also to some extent in the libraries of the former colonial countries. These periodicals, in my opinion, form a contested space of dialogue, where the colonial masters and the colonized, as time progressed, debated and mediated various issues, from the utility of colonial regulations to the notions of freedom from the colonies. These periodicals contained information about events around the globe as well as news of local importance. These periodicals potentially could have contained preposterous claims that lack any evidentiary value. Also, the information that might be contained within these periodicals might lack any evidentiary value or it couldn't have been authentic at all. However, irrespective of the propositions that I have made earlier, I would argue that these periodicals are heritage materials and that these periodicals represent to us the records of colonial interactions.

However it is not the simple mining of information from these records that helps us in enhancing our understanding of the colonial modalities. We believe that their "form and placement", as elaborated by Stoler, is important in understanding the notion of "knowledge production" (Stoler, 2002, 91).<sup>2</sup> With an increasing discussion about the nature of what an archive is, what is a record and who should be steward of these records, various questions about the status of these periodicals remain open for debate. Why would an independent nation preserve these memories of colonial repression and dominance, while the preservation priorities in the developing world are limited by the amount of material sources that are available for such activities within a library or an archival setting? If these periodicals represent a notion of a particular identity for the newly independent nation, then what aspects of these identities might

be perceived as a threat to the creation of a uniform, regularized core identity on upon which nations often tend to rely?

The notion of prioritization as understood in a post-independent context for a developing world nations might mean, allotting the meager resources for the preservation of the "other" heritage materials such as pre-colonial manuscripts. For the former colonial masters, the loss of colonial territories might indicate that some of the activities that were reported upon in these periodicals might not be conducive to the fostering of an atmosphere of good will with the former colonial enclaves. Thus these periodicals today might be relegated a back burner status in the post-colonial discourse. This perceived absence of interest in French language periodicals in India can be only partially explained by the "disenfranchised" status of Indo-French communities in the political matrix of modern India. These communities can be thus defined not as the subjects of the former colonial powers but as the subjects of these periodicals. This process of translocation of the status of the former "enfranchised" communities into "homogenized" community within Pondicherry and other French territories in India will help us understand the reasons for the demise of these periodicals and their current status in the preservation matrix of India.

One way to document these various modalities of colonial interactions between the French and the local communities within the Indian sub-continent is the carry out limited discourse analysis of what was written and published in these periodicals. However, currently, we do not have a complete bibliography of French language newspapers and journals that were published in India from the period of 1701 till 1954. The main purpose of this grant proposal remains; creating a web based annotated bibliography of these periodicals that are currently located in India. Two of the major repositories where these periodicals are currently located in

India are in the town of Pondicherry. These repositories are the public library of Pondicherry and the French Institute of Pondicherry.

## **Historical Background:**

It is well-established fact that the substantive French presence and imperial drive in the Indian Sub-continent ended after 1763, and French possessions in India were subsequently limited to several smaller land pockets (Miles 5)<sup>3</sup>, namely Pondicherry (Pondichéry), Karikal, Mahé, Yanaon and Chandernagor. Pondicherry and the other French territories continued to exist surrounded by newly independent milieus and separated by large distances till the *de facto* transfer of the territory on November 1, 1954. However, the milieus that provided and to an extent nurtured the amalgamation of Indian and French identities were destined to disappear in the foreseeable future.

The French presence in India remains a relatively under-studied aspect of the genre of colonial and post-colonial writings, especially when compared to the level of scholarship on the French presence anywhere else on the globe. In particular, much has not been written about French colonial interaction within South Asian milieu and its meaningful interstitial ambivalence<sup>4</sup> when it came to defining, understanding and dealing with so called "natives". Some scholars have even argued that the thwarting of French "physical" Imperial ambitions in India were compensated by the search for and creation of "an epistemological space" that was necessary for fictional occupation and understanding of those whom they colonized. <sup>5</sup> One problematic of this attempted creation of an ontologically viable "epistemological space" arises

from its fictional nature. This is further complicated by a complex task of "defining boundaries of this space". This modular understanding of a space or even spaces engages the interconnectedness of the colonial space with the space of the mother country. One way to extend scholarly understanding of this ill-defined space is to try to map it by using cultural artefacts that depict actual events of the time.

One of the earliest cultural artefacts of French colonial existence in India is a group of French language publications that were published in India. Taken as a group, these colonial publications are extremely interesting as they contain not only "delayed breaking" news from the Metropolitan France, but also report the daily administrative transactions that characterized the French colonial milieu in India. These transactions are of particular interest to those who seek to understand and decode daily colonial discourse and what it represented to the literate élite within these colonial enclaves. These publications also reveal various characterizations of the often troubled relationship between the colonial populace and metropolitan France.

Today, these publications are primarily held in two geographically disparate locations: the Bibliothèque Nationale in Paris, and in India at the library of the French Institute of Pondicherry (FIP), at the Public Library in Pondicherry. There are over 70+ rare French publications at the FIP that cannot be located through any of the North American library databases. The earliest periodical in the holdings of the FIP library is the *Bulletin des actes administratifs des Établissements français de l'Inde*. This was the first French newspaper to appear in French India in 1823. The FIP holdings overall span the 1830s to the mid-1960's.

until 1957 was "Le Trait-d' Union" This is an interesting newspaper for several reasons: it was established one year before the independence of India from Great Britain, and its editorials reflects upon the realities of society of newly emerging secular Indian state, and the French Indian community.

Because they were originally intended to be ephemeral, and tend to be printed on acidic paper in outsize formats, newspapers and periodicals everywhere pose significant preservation concerns for libraries and archives. In environments where preservation resources, including expertise, are scarce and the climate is not conducive to preservation, the effects of aging and neglect are exacerbated. The newspapers at the FIP Library are in critical need of systematic preservation efforts. Although the purpose of my grant application to LAUC State-wide grant is not the actual preservation of these periodicals, but to create an annotated bibliography of these periodicals that can then aid the researchers and librarians likewise in their pursuit of enhancement of the understanding of colonization and also in planning of proper preservation strategies.

## **Site Description:**

Romain Rolland Public Library is of the very old libraries in India and the erstwhile Bibliotheque Publique, Romain Rolland Library is named to honor Romain Rolland, a close associate of Mahatma Gandhi and a French scholar. The library has a collection of more than 315,000 volumes in many languages. Mobile library facility with more than 8000 books is another feature, which is very useful to the rural people. The library is also serves as a major repository of the colonial era French publications. Library is open all days except Mondays and holidays from 7:30 am to 4:30 pm.

French Institute of Pondicherry was established as a result of framework of the Cessation Treaty of French Territories in India, and was officially inaugurated on 20 March 1955. The library's website describes it as follows, "The library of the French Institute of Pondicherry is a multi-disciplinary research library. Its collection was started with the founding of the Institute in 1955, and was constituted over the years with the active collaboration of the Institute's researchers. Today the library has a rich and varied collection of books and journals relating to the cultural knowledge and heritage, contemporary social dynamics and environment and sustainable development, of India, and more generally of South Asia. As of today, the collection consists of 60 000 books, 300 theses, over 1000 articles and 800 journals of which 260 are received currently. Between 1500 and 2000 books are added to the collection every year". 9

#### Need for Research and Area Studies context at UCLA:

As the librarian for South Asian Studies at UCLA, I have strived to support faculty and graduate student research on continual basis for the past three years by providing them bibliographic instructions, by participating actively in various aspects of the collection development of the related materials in various languages. In 2006, UCLA established the "the Center for India and South Asia". The goal of this center is to transform UCLA into one of the leading poles of integrated research activity on India and South Asia in the country through research, collaboration and academic integration. The Young Research library serves as a go to resource for Social Sciences and Humanities graduate students and faculty members. The field of South Asian studies is an interdisciplinary field and the faculty members that are affiliated with the center reside in various academic departments. Library support, in my opinion thus must focus on the needs of both the center and various South Asian studies faculty members.

The director of this center is a well-know historian, Dr. Sanjay Subrahmanyam, who specializes in French and Portuguese colonial history of South Asia. Besides, Dr. Subrahmanyam, there are several other faculty members that are interested in studying various aspects of French colonization in Indian sub-continent. These scholars include, Dr. Aamir Mufti, Dr. Francoise Lionnet, and Dr. Nile Green.

Dr. Mufti is from the comparative literature department who specializes in South Asian

Literature and Critical Theory. His academic training is in literature and anthropology, and his areas of specialization include: colonial and postcolonial literatures, with a primary focus on India and Britain, and nineteenth- and twentieth-century Urdu literature in particular; Marxism and aesthetics; Frankfurt School critical theory; minority cultures; and the history of anthropology. He is the author of Enlightenment in the Colony: The Jewish Question and the Crisis of Postcolonial Culture (Princeton, 2007) and co-editor of Dangerous Liaisons: Gender, Nation, and Postcolonial Perspectives (Minneapolis, 1997). His work has appeared in such periodicals as Social Text, Critical Inquiry, Subaltern Studies, boundary 2 and the Village Voice.

Dr. Françoise Lionnet of French and Francophone Studies, whose specialization has been French colonial modalities and post-colonial interactions in the developing world nations, is also interested in this project as she found it to be surprising that there wasn't any annotated bibliography that was dedicated to this subject. Dr. Françoise Lionnet is Author of Autobiographical Voices: Race, Gender, Self- Portraiture (Cornell, 1989), and Postcolonial Representations: Women, Literature, Identity (Cornell, 1995); co-editor of a special double issue of Yale French Studies entitled "Post/Colonial Conditions: Exiles, Migrations, Nomadisms", and a special issue of Signs on "Postcolonial, Indigenous, and Emergent Feminisms."

Dr. Nile Green of History department is interested in Islam in colonial India. There hasn't been any study of the nature of Islam in the French colonies on the Indian sub-continent and he might be interested in if and how Islam was portrayed in these French-Indian periodicals.<sup>13</sup>

Besides the campus based interest in these periodicals, I want to take in consideration the interests of academia and librarians in North American setting. I believe that the proposed project will create a resource that can be used widely by the North American academic community.

## **Proposed Time Line and Site Description:**

#### **Process:**

- Visiting Romain Rolland Library and the Library of the French Institute of Pondicherry and Assessing conditions of French language Periodicals of Colonial India
- 2. Identifying the Indo-French Periodicals and analyze their contents for annotations. I have started to create a preliminary list of these periodicals using the electronic catalogue of Bibliothèque nationale de France. I expect to spend the majority of my time looking at the contents of these periodicals in order to create an annotated bibliography.
- 3. Although not the part of the grant proposal that requires funding, I will spend a limited amount of time identifying and selecting periodicals that can be possibly microfilmed. (This expense is not included in the LAUC Grant proposal Budget; please note the explanation for the items 3 below in the body of the text).

Phase I: Travel to Pondicherry, India

I will travel to Pondicherry, India and assess the condition of the public domain periodicals of French India at the French Institute of Pondicherry and Romain Rolland Pondicherry Public Library. I am requesting 10 working days worth release time for completing my research in Pondicherry, India. These days, I fully plan to spend at the Pondicherry Public library and the library of the French Institute of Pondicherry in order to look at the actual periodicals, i.e., journals and newspapers. During my stay in Pondicherry, I will take descriptive notes on these periodicals that will help me in creation of the annotated bibliography as I work and after my return back home. I have been successful in contacting the chief librarian Ms. Anurupa Naik of the French Institute of Pondicherry and she has shown interest in helping me in the process of creating this annotated bibliography of French language periodicals of India. As stated earlier, I have created a preliminary list of French language periodicals that were published in India. However, I must admit that the French National Library does not have all of the periodicals that were published in the French comptoirs of India. However the list of the titles will help me focus on looking at the content and the subject matters of these periodicals. I believe that I can achieve this task successfully in 10 working days. I was able to gather a list of 60 periodical titles that are currently in catalogue of French National Library. The list is included in the Appendix.

Optional Component to be funded partially by my own South Asian Studies Funds and possible SAMP-CRL Contribution:

I am not soliciting any additional funding for microfilming from LAUC. However, I am considering applying for the CRL SAMP (South Asian Microform Project) funding and also I

have my own South Asian Studies funds. I plan to dedicate a small part of these funds for the acquisition of these microfilms. The estimated budget that is needed for microfilming of these periodicals is derived is as follows:







Dear colleague

I am writing in strong support of Liladhar Pendse's application for funding for his bibliographical project, 'L'Inde Française.'

As one of several historians of India working in the history department at UCLA, I have a natural interest in improved access to and information about archival and rare printed materials in India. Each year my departmental colleagues and I admit doctoral students to our program and one of our principal criteria for admission is their command of a relevant European as well as an Indian language. There will, then, be a local demand for the bibliography that will naturally be amplified by its wider audience beyond UCLA. While I should add that my own sphere of research interest does not include French India – I have, then, no vested interest in the project – I am fully of the opinion that the periodicals published during the several centuries of French presence in India are an important if almost entirely neglected resource for researchers.

In practical terms, what is particularly important about the French language material is the possibility it opens up for researchers to access another dimension of Indian history through the relatively accessible language that is French. While most scholars of India tend to acquire only one Indian language, the existence of another body of materials in a comparatively easy European language opens the possibility of complicating and enriching a historical picture usually dependent on either solely English archives or the 'English plus one Indian language' formula. Mr Pendse has already proven the feasibility of such a project with regard to Indo-Portuguese materials and has identified a similarly feasible and highly worthwhile project with regard to the French materials in question.

As a scholar who has spent a good deal of time working in Indian libraries, I can fully testify to the usefulness of the project. I have often had to see a good deal of my own time wasted through 'on-the-off-chance' visits made to Indian libraries which lack such digitized (or even printed) catalogues of their collections. The availability of the bibliography which Mr Pendse envisages would therefore not only further awareness about the scope and location of such French materials, but also encourage scholars to make research trips to the libraries concerned through the assurance that their visit would be worthwhile.

I strongly encourage you to support this project.

The importance of print newspapers and journals as one mechanism for the expression of colonial dissatisfaction, alienation and associated rise of nationalism in French India remains an understudied fact. The beginning, apogee and end of French press in India can be understood as one valuable tool that would allow us to interrogate the complex mechanisms that eventually lead to the rise of Indian and Indo-French national identities. French language periodicals that were published in French India (1701-1954) remain an excellent source of such information. These periodicals provide us with a new perspective on mechanisms of colonization, cultural production, public sphere and subsequent decolonization within the French held territories of India. These periodicals are often overlooked by researchers in North America who study colonial theories due to the difficulty of access. The proposed project will address the difficulty of access issue in several ways. First, under this project a comprehensive web-bibliography of these French periodicals of colonial India will be created. The majority of these non-catalogued periodicals are scattered in the public libraries of former French colonial enclaves of Pondicherry, Chandernagore, Karikal, Mahe and Yanaon in India. Second, a research paper related to the complex processes of French colonization in India will be presented in an academic setting. I believe that this project will enable the North American specialists that are interested in studying the specificities of French colonization add an unique dimension to their research on social conditions and popular culture in the colonial India and the colonial power-France.
