- 1. To create a comprehensive annotated bibliography of the periodicals of Azerbaijan from 1875 until 1920.
- 2. Second, this bibliography will be either published as a book or mounted on the web at UC Berkeley Library following the Open Access principles. This bibliography will be searchable by editor, title, place of publication, and annotations. Additional fields can be added as needed. Indirect Project Goals:

Although the goals no. three and four are not required as a part of this grant application, I believe that these point towards my commitment to this proposed yearlong project.

3. To publish a peer reviewed article that would examine the modes formation of "new" Azerbaijani identity in the ADR through the purposive content analysis. A special attention will be focused on the perception of minorities, women and surrounding nations like Iran, Russia and Turkey as it appears in the editorials and fictional works within these periodicals or to present to UC Berkeley Library staff findings of my research.

4. Desideratum/ Optional- Not to be funded by the LAUC Research Grant funds: To acquire microfilm copies of up to 3 titles of 19th century Azerbaijani language periodicals from Baku.

Introduction and Statement of Problem:

The periodical press of the late 19th century Azerbaijan and its society as a part of the Czarist Russia and in the early 20th century as the Azerbaijani Democratic Republic (ADR) represents a unique social laboratory. In the current Library and Information Studies related academic literature, we hardly find any study that undertakes analysis of and bibliographic descriptions of these periodicals for a historically significant time period of Azerbaijani history.

During my several searches in the databases such as Academic Search Complete, Library Literature and Information Full-text, and Library, Information Science and Technology Abstracts (LISTA), I could not find single relevant reference to a group of periodicals that I plan to use to create the annotated bibliography.

These periodicals as a group represent a diversity of unprecedented proportions. This diversity is reflected not only through the publications in many languages that include Azerbaijani, Armenian, Georgian, German, Laz, Russian, and others. These periodicals were published in various formats and genres. There hasn't been a systematic bibliographic study of these periodicals that would capture not only the enriching diversity of these publications but also the influences that these publications had experienced due to proximity of Ottoman Empire in Turkey and Qajar period Iran.

In the post-Czarist Russia, Azerbaijan Democratic Republic was the first democratic and secular republic in the Muslim world. Despite of its relatively short existence from May 1918 until its forceful Sovietization in April 1920, there was flowering of Azerbaijani press that reflected altruistic principles of a peaceful society in turbulent times. The purpose of this project is three fold. First, I will create a comprehensive annotated bibliography of these periodicals of Azerbaijan from 1875 until 1920. Second, this bibliography will be either published as a book or mounted on the web at UC Berkeley Library following the Open Access principles. Third, I would work on a peer reviewed article that would examine the modes formation of "new" Azerbaijani identity in the ADR through the purposive content analysis. My publishable work will also focus on the answering following questions,

What kinds of topics are covered in Azerbaijani literature that is published in these periodicals? What are the major themes that these periodicals adhere to? Do they show what life is like in Baku? Do they give clues as to the characteristics and values of Azerbaijanis? How are the various genders, ages, classes represented? Do the depictions and subject matters change between different eras, i.e. prior to independence of Azerbaijan from the Russian Empire and during the era of the Azerbaijani Democratic Republic? I am particularly curious to see the differences in the representations of women from the colonial period to contemporary times.

The fourth objective of this study for which I will not use any of the LAUC grant money is to see, if I can acquire microfilms of up to 3 titles at no costs to the LAUC and UC Berkeley Library.

About Azerbaijan:

Azerbaijan is a nation that is located in Transcaucasia and it is bordered by Georgia, Armenia, Russia, Turkey (with Nakhchivan) and Iran. It is a newly independent country that emerged after the fall of the Soviet Union. Azerbaijan is in fact an ancient land that can be described as a country that is at the crossroads of numerous, cultures, religions, and civilizations. The CIA's the World Factbook describes it as follows,

"Azerbaijan - a nation with a majority-Turkic and majority-shia Muslim population - was briefly independent (from 1918 to 1920) following the collapse of the Russian Empire; it was subsequently incorporated into the Soviet Union for seven decades.

Although the poverty rate has been reduced in recent years due to revenue from oil production, the promise of widespread wealth resulting from the continued development of Azerbaijan's energy sector remains largely unfulfilled."²

Historical Background:

In the 19th century Russian Empire, the territory of the current Republic of Azerbaijan was incorporated as *Bakinskaia Guberinia* in 1859. The *Bakinsksia Guberniia* was a multiethnic, multi-lingual province with its center as Baku on the Caspian Sea. The drilling of the first oil well in *Bibi-Heybat* in 1846³ and subsequent development of the petroleum industry in Azerbaijan ushered in the rapid economic growth in the region. With growth the diversification of population and the social stratification of the region also intensified that could have led to the increased cultural consumption that indicates appearance of various periodicals in the region.

The diversification of population and multi-ethnic milieu of Baku and its surroundings is evident in the data gathered from 1897 Census of Russian Empire. The census shows that in Baku during the census there were a total of 169,995. Out of this population there were approximately 53% Azerbaijani (Azeris). The term that the Czarist official employed was *Магометане* or Magometane. There were 13% Armenians (*Армяно-Григориане and Армяно-Католики*), 6% Jews, and 23% Russian Orthodox (*Православные и единоверцы*). The discussion of the Census terminology of Russian Empire in 1897 might be problematic and beyond the scope of this proposal. However, the census data demonstrates the diversity of the

population of *Bakinskaia Guberniia*. In census of Russian Empire, the term that was used to denoted the Azerbaijanis was either "the Muslims" or "the Shirvan Turks" or "Turks" or "Azeri Tatars" or simply "Tatars." This has also added to the lack of understanding of what constitutes an Azerbaijani periodical? I argue that the periodicals that were published during the period of the late 19th century in Azeri language constitute a group of periodicals that are to be collectively understood as Azerbaijani periodicals.

The first Azerbaijani language serial that appeared in Baku was the newspaper entitled, "Ekinci" in 1875. "Ekinci" had to undergo a strict review by the Czarist censors and despite of its educative, informational characteristic it was eventually shut down due to various reasons. One of the main reasons for its shut down was the impending war between the Russian Empire and the Ottomans in 1877-78. The periodicals press nevertheless continued to be published in Azerbaijan. The languages of these periodicals varied according to the languages of the communities that had published them.

There are varying accounts of how many periodicals titles were published in Azerbaijan during the period beginning 1875 through 1895. The bibliographic data that exists on these periodicals, their contents, and periods of circulation is scant for several reasons. First, after the Sovietization of Azerbaijan these periodicals could have been possibly declared as representatives of bourgeois ideology and suppressed. Secondly, there were several language reforms in Azerbaijan that changed the script of Azerbaijani language. Thus any bibliographic works that were published on these periodicals were rendered inaccessible to most of the Azerbaijani masses. This in turn can be construed as not the loss of the historical memory about the periodicals press of the whole group of people, but as the loss of access to it. I argue that creating a comprehensive annotated bibliography along with some digital images of the title pages of these periodicals might help in providing access of Azerbaijani people to their historical memory.

Site description:

For the purpose of my proposed project, I have identified several key sites in Baku where these periodicals are located. These sites are as follows,

- 1. The library of the Baku State University (Primary site).
- 2. The National Library of Azerbaijan (Milli Kitabxana) (Primary Site)
- 3. The former archive of the Communist Party of Azerbaijan. (Secondary Site).
- 4. Library of the Institute of Manuscripts of the Academy of Sciences, Baku.

The Baku State University Baku State University (*Bakı Dövlət Universiteti* or BSU) is a public university located in Baku, Azerbaijan. The BSU was established in 1919 by the Parliament of Democratic Republic Azerbaijan. The School of Library and Information Studies of the BSU is instrumental in preparing the librarians for Azerbaijan. Besides the LIS program, the Department of History cooperates closely with the university library that has major holdings of periodicals that were produced during the epoch of Azerbaijan Democratic Republic. I have already established contacts and received commitments from the several tenured faculty members of the Baku State University with respect to their assistance in my research. I am attaching letter of support from a tenured professor of History department of the Baku State University (http://history.bsu.edu.az/en) with this application. The University Library has several

runs of periodicals from the period before the Sovietization that can be accessed to create this bibliography. The Baku State University's Department of History has agreed to provide me with the needed support so that I can complete my research in a timely fashion. Please see Appendix VII for the letter of support from Dr. Altay Goyushov.

2. The National Library of Azerbaijan (*Milli Kitabaxana*) in Baku serves as the historical repository of the materials that were published in Azerbaijan during the period of Russian colonization, and during the Republican period. Also, the Milli Kitabxana contains periodical runs of Azerbaijani periodicals that were published in Tbilisi, Georgia as well as in Derbent, Russia.

The other two sites, I have denoted as the secondary sites for data collections for several reasons. First, the National Archive of the Former Communist Party of Azerbaijan restricts access to its collections and a prior permission has to be obtained from the section on information of the Presidential administration of Azerbaijan. I am currently in email contact with the head of the Presidential administration of Azerbaijan with respect to the access to the periodical runs of pre-Soviet period that are under the jurisdiction of the former party archive. The library of Fuzuli Institute of Manuscripts of the Azerbaijan's Academy of Sciences is another depository that primarily contains manuscripts but could have print runs of Azerbaijani periodicals. I have sent an email query to see if I can get the list of these periodicals from Dr. Farid Alakbarli who is the Head of Department of Translation and Information of the M.Fuzuli Institute of Manuscripts of the Azerbaijan National Academy of Sciences.⁷

Need for Research and Area Studies Context at UC Berkeley:

As the Librarian for Slavic, Eastern European and Eurasian Studies at UC Berkeley, I have strived to support my faculty, both graduate and undergraduate students on continual basis since my arrival to UC Berkeley in September of 2012. Since my arrival, I have conducted several one on one research consultations with both Graduate and Undergraduate Students. In addition to these research consultations, I hold now my walk-in office hours in the department of Slavic Languages and Literatures, where I consult students on their topics for the term research papers. Besides, my liaison role in the Department of Slavic Languages and Literatures, I regularly meet with and consult the faculty in History department and attend the meetings of the Institute of Slavic, East European, and Eurasian Studies serves as the focal point at the University of California at Berkeley for students and faculty who conduct research and teaching on the geographic region of the former Soviet Union and Eastern Europe. Currently the Institute has 45 core UCB faculty members and over 150 affiliated graduate students.⁸

The Institute also has several visiting scholars from the Caucasus and the Central Asia. As the librarian who is responsible for the instructions for the institute, I have conducted several instructional sessions to these visiting scholars. The Doe-Moffitt's Caucasus/ Central Asian and Eastern European Studies collections serve as a go to resource and I believe that my project will contribute positively to the existing collections.

The proposed project also fits in well within the framework of the recently launched initiative at UC Berkeley, "the Berkeley Caucasus/Caspian littoral initiative has been institutionalized through the establishment of the Caucasus and Central Asia Studies Program

(CCAsP) under the auspices of the Institute of Slavic, East European, and Eurasian Studies (ISEES). According to Professor Sanjyot Mehendale, the program has secured funding from the National Security Education Program, as well as from the Ford Foundation through the Institute of International Studies. The NSEP grant will include funds for workshops/ conferences, visiting scholars, a visiting speaker series, graduate fellowships, language training, and administrative support.

My project will also cover all of the Armenian periodicals that were published in Baku and Azerbaijan during the Czarist Russia and the Azerbaijan Democratic Republic.

Larger Academic Context:

Besides the campus based interest in these periodicals, I want to take in consideration the interests of academia and librarians in North American setting. I briefly surveyed my librarian colleagues in the field of Eurasian Studies and realized that to this day there wasn't any comprehensive annotated bibliography of these periodicals available in the West.

I believe that this bibliography and my original research that is associated with it will allow me to fill in the existing gap in the field of bibliographic research on the periodicals press of Caucasus region. I believe that the proposed project will create an open access resource that can be used widely by the North American academic community who are not only interested in the print history of Azerbaijan and Caucasus, but also in the subject areas of Cultural Anthropology, Sociology, History of Ottoman and Russian relations, Russian relations with Iran, History of this multi-ethnic, multicultural region.

Proposed Time Line

- 1. Visiting Baku State University's Library and the National Library of Azerbaijan in Baku. Also visit the secondary proposed sites of the Library of the former Communist Party of Azerbaijan Archives and the Library of the Fuzuli Institute of Manuscripts of Azerbaijan.
- 2. Identifying the Azerbaijani, Armenian, Russian and periodicals in other languages that were published in Azerbaijan during 1875-1920 and analyze their contents for annotations. I have started to create a preliminary list of these periodicals using the electronic catalogue of the National Library of Azerbaijan. I expect to spend the majority of my time looking at the contents of these periodicals in order to create an annotated bibliography.
- 3. Although not the part of the grant proposal that requires funding, I will spend a limited amount of time identifying and selecting periodicals that can be possibly microfilmed. (This expense is not included in the LAUC Grant proposal Budget.)
- 4. Creating searchable database using Microsoft Access and mounting of the database on the UC Berkeley's bSpace Server (awaiting feedback from the systems office to see if 1 can use the MySQL.)

Phases of the proposed project:

Travel to Baku, Azerbaijan.

I will travel to Baku, Azerbaijan and assess the condition of periodicals that were published in Azerbaijan from 1875-1920 at the Baku State University's Library and the National Library of Azerbaijan. I am requesting 10 working days' worth release time for completing my research in Baku, Azerbaijan. These days, I fully plan to spend at the Baku State University's Library and at the National library of Azerbaijan.in order to look at the actual periodicals, i.e., journals and newspapers. During my stay in Baku, I will take descriptive notes on these periodicals that will help me in creation of the annotated bibliography as I work and after my return back home. I have been successful in contacting the chief librarian Dr. Karim Tahirov of the National Library of Azerbaijan, who has offered his assistance in my project that will lead to creation such important resource on the materials published in Caucasus area.

As stated earlier, I have created a preliminary list of these periodicals that were published in Azerbaijan. I believe that I can achieve this task successfully in 10 working days. I was able to gather a list of 17 periodical titles that are currently in holdings of the Azerbaijan's national library. The list is included in the Appendix. It is not the comprehensive list as many of these periodicals are in the backlog of the libraries that I mention.






Form for searching the periodicals.

In the late 19th and early 20th centuries, Azerbaijan was one of the most rapidly developing and volatile parts of the Russian Empire, and Baku – the country's oil capital – was one of the most dynamic, wealthy, and violent cities in Eurasia. This letter is in support of Mr. Liladhar Pendse's application for a research grant from the Librarians Association of the University of California.

Mr. Pendse's research project "Improving Access to Azerbaijani Periodicals: 1875-1920", will fill a current bibliographic gap in scholarship about periodicals published in late 19th to early 20th Century Azerbaijan. Holdings of Azeri periodicals from this period in most American academic libraries are mainly limited to the Azeri publications contained in the UMI-Norman Ross "Late 19th to Early 20th Century Central Asian Serials" microfilm collection which was done in the mid-1990's. As a result, the majority of Azeri periodical titles for this period listed in commonly used bibliographical tools such as OCLC Worldcat are for the most part limited to those which are in the UMI-Norman Ross collection. Mr. Pendse's project will capture bibliographic information of the many Azeri periodicals which were not included in the UMI-Norman Ross collection. Since the UMI-Norman Ross microfilm collection was based on the holdings in the Russian National Library, Mr. Pendse's proposal to go to Azerbaijan would allow him to survey the presumably much larger Azeri periodical holdings of libraries and archives in Azerbaijan itself.

Here at the University of Wisconsin-Madison, the Azeri language is taught on a regular basis and courses are also taught which include instruction on Turkic languages in the Arabic script. So resources such as the UMl-Norman Ross materials in Arabic script Azeri are used here on a regular basis. Judging by this usage, other Azeri periodicals which Mr. Pendse may uncover in the course of his project will be of great scholarly interest as well. UW-Madison has also had graduate students who have gone to Azerbaijan to do research in the libraries and archives there. Therefore, I am confident that bibliographic information on what periodicals may be found in Azeri libraries and archives would be of great use to scholars both at Berkeley and many other institutions of which UW-Madison is only one.

Therefore I support wholeheartedly and without reservation Mr. Pendse's application for research funding for his project.
