A. Summary and current status of the research project/activity

In December 2012, Cynthia A. Johnson (Head, Reference, at UCI Libraries) and I submitted a proposal for a lightning talk/breakout session at the 2013 LAUC-B conference, "Making it Count: Opportunities and Challenges for Library Assessment," which will take place on October 25, 2013 at UC Berkeley. On January 4, 2013, we were notified that "the Planning Committee is intrigued and excited about your topic and would like to invite you to present it as a Poster Session instead." We accepted the invitation and will add a laptop to the poster to demonstrate our in-house RefStats system and the reports it generates. By October 2013, we will have a full year's worth of experience and data. Our poster presentation is entitled Better Ways to Count Reference, in order to Count on Reference.

Abstract:

In October 2012, UC Irvine launched a new program for recording and reporting reference statistics on and off the reference desk. This poster will review:

- why we decided to create an in-house program rather than buy an off-the-shelf product
- the information we are capturing that may not be considered traditional for reference statistics
- the reports we are able to generate
- how we are innovatively using our reference statistics to staff and understand better our in-person reference services at our service points, and for individual librarians to understand better their individual work with faculty and students that takes place separate from the traditional reference desk
- ideas for using this data to connect to other data the UCI Libraries capture, to give us more granular details about how our patrons use our services

Our poster will describe what kinds of assessment and statistics can be recorded for reference interactions. We will also include ideas about how UC libraries can use the data we capture

from our reference services to assist in demonstrating the value libraries add to the university's mission. We will also have a laptop to demonstrate how the system works and the reports we can generate.

After a roll-out of the new RefStats program on October 1, 2012, the interface was revised, enhanced, and rearranged in response to user feedback. Most of the changes have been implemented, so the current focus is on the kinds of reports we would like it to generate. Design Services would like to see the content for the poster by early August, so in February-July we will be collecting ideas from those using RefStats to see what kinds of reports we need and examining ways in which we can use the data we are collecting.
