### **TITLE OF PROJECT: Overview of New Developments in Major Academic Databases**

Original Abstract as Submitted:

The development of commercial e-resources in China only started in early 2000. The digital publishing industry in China has developed quickly and improved considerably since then. They have learned from experience and practices in the US and European countries, and have gradually complied with international standards. In recent years, there have been considerable new developments in e-resources produced in the US, which have made the use of e-resources easier and more adept to teaching and research. East Asian libraries and users would like to see the same new developments happening in Chinese e-resources as well. My paper will review the new developments by discussing major English databases, and study how these new developments can be applied to Chinese e-resources. The study would encourage Chinese publishers fully complying with international standards, and use the best practices shared by publishers in the industry.

It is also a great place to advocate what libraries and librarians like to see in e-resources in terms of content, format and technology. My presentation was well**

**received; I had more discussions on this topic with some attendees during the conference.**
